#### **Project Overview & Objectives**

#### MAIN GOAL OF THE PROJECT

Assist in the process of generating knowledge and awareness of the benefits derived to all stakeholders from a European Student eID Credential

Fostering dialogue with the relevant stakeholders through a series of workshops, conferences, surveys, research projects and dissemination of information using various platforms.







#### **Project Objectives**

- 1. Engage in a process of dialogue with the relevant stakeholders to seek out their views and opinions on the needs and requirements of a trusted Student eID Credential that supports cross-border services.
- 2. Identify the barriers that excludes stakeholders from enjoying the full benefits of a trusted eID that will enable access on a cross-border basis to both academic and non-academic student services.
- 3. Establish recommendations for the development of a proposal for a trusted student eID framework that will support the provision of secure identification and authentication on a cross-border basis in Europe.
- 4. Promote innovation and networking, particularly in the education, business and technological sectors, associated with the use of a cross-border student eID that supports student mobility and access to student services across Europe

No.	Project	Start/End	Grant	Details
1	e-Signature and Erasmus Student eCard in Greece	Sept. 2018 to March 2021	€270,400	This project aims at promoting the uptake and use of eSignature in the Greek Public Administration and the use of cross-border eIDs among ERASMUS students.
2	Erasmus without Paper (EWP1.0 & EWP2.0)	Completed December 2019	€499,982 €499,613	Supports the electronic exchange of student data and information by interlinking the existing Erasmus student information systems in HEIs.
3	EMREX Project	Completed 2017	€1,425,000	This project focused on increasing international student mobility by enabling electronic exchanges of student achievement data between HEIs in the EU.
4	European Student Card	Completed June 2018	€292,223	The ESC project focused on enabling students to assert their rights by connecting existing student cards to a digital system, which would allow communication between the HEIs Information Systems in Europe.

No.	Project	Start/End	Grant	Details
5	MyAcademicID	Jan. 2019 to Dec. 2020	€1,039,639	MyAcademicID aims to support a digital infrastructure for secure and seamless exchange of data between higher education institutions in Europe and to allow students to authenticate online and access e-services through a single sign-on solution.
6	SEAL	April 2019 to March 2021	€1,188,121	The SEAL project aims at combining the benefits of EU citizens, student and researchers identities to enable a cross-sector interoperability between eIDAS and Higher Education/Research domains.
7	StudIES+	Completed Dec. 2019	€1,421,253	StudIES+ was focused on developing a solution for digital student identities and the mobile student card, as well as secure and certified document exchange based on eIDAS Regulations.

No.	Project	Start/End	Grant	Details
8	Olympus Project	August 2021	€2,564,480	OLYMPUS will address the challenges associated to the use of privacy-preserving identity management solutions by establishing an interoperable European identity management framework.
9	Cross-border authentication in European cloud platforms	Oct. 2018 to Sept. 2020	€598,952	This project will integrate the eID Digital Service Infrastructure into the systems of three Electronic Data Interchange Providers (EDI) and one public university, that will be connected to four different eIDAS nodes in Belgium Cyprus, Italy and UK. This will make different services available for cross-border authentication
10	eID4U	Completed October 2019	€584,314	The eID4U project aim was to use the eIDAS electronic identities to provide advanced cross-border services to the European academic environment.

No.	Project	Start/End	Grant	Details
11	European Digital University Card Student (EDUC)	Sep. 2019 to Aug. 2022	€183,896	The objective of this project is to set up the European Student Card in the mobility space that the EDUC alliance offers, and to test an operational framework for its deployment, to identify any potential difficulty and develop solutions to overcome potential problems.
12	European Digital Student Service Infrastructure (EDSSI)	Commence Oct. 2020	€2,499,309	The objective of this project is to design, develop, and roll-out a technical infrastructure to support European HEIs in offering to students a secure cross-border eID and authentication as well as cross-border electronic exchange of data required by online student services.
13	EU Student Card Extension and Adoption (ESC- tension)	Nov. 2020 to Oct. 2022	€299,138	This project will focus on the need to have a "focal point" at national level of Member States to facilitate the adoption of the European Student Card by the HEIs and by the students. The project develop resources and tools to adapt the local student charter and student services to ESC standards.


